Evropska skupnost za javne zadeve (PACE) je bila ustanovljena leta 2011 kot skupna platforma za vse nacionalne organizacije evropskih strokovnjakov za javne zadeve in lobistov. Public Affairs Community of Europe je evropsko združenje, katerega cilj je združiti nacionalna združenja po vsej Evropi, ki temeljijo na treh stebrih: raznolikost, evropski doseg ter visoki standardi etike in preglednosti. PACE organizira letno srečanje o javnih zadevah, ki vsako leto poteka v drugi evropski prestolnici, tokrat v Ljubljani.

The Public Affairs Community of Europe (PACE) was established in 2011 as a common platform for all national organizations of European public affairs, professionals and lobbyists. The Public Affairs Community of Europe is a European association which aims to gather national associations across all of Europe and is based on three central pillars: Diversity, European outreach and High standards in ethics and transparency. PACE organizes an annual public affairs summit which is held in a different European capital each year, this time it is the turn of Ljubljana.
